The owner agrees to:

1. Pay all boarding and training charges by the first month in accordance with our current rate sheet. Board received 5 days or more before the first of the month will be discounted \$10.00. (Board checks received before the first will not be deposited until the first.) There is a \$25.00 late fee on all payments not received by the tenth of the month. Last month's board is due within 3 months. There are no board refunds.
2. Grizzly Peak Stables shall have and is hereby granted a lien for any and all unpaid board and other charges resulting from boarding and/or training of horse described on the boarding agreement. Board that is overdue 30 days may result in moving the horse from the current location at the discretion of Grizzly Peak Stables. If, 10 days after written notice to the owner at the address listed on the boarding agreement, the debt is not reconciled, horse may be disposed to satisfy the charges at private or public sale and the owner waives all other legal notice. In the event the sale does not secure a price sufficient to pay costs and charges, the owner shall be liable for the difference. Any sum realized over and above the costs and charges shall belong to the owner.
3. If the animal becomes ill or is injured, the owner shall be notified at the above telephone numbers for instructions, and if the owner cannot be informed or does not answer the notice or the horse's health requires immediate action, Grizzly Peak Stables shall have the right to use its best judgement in regarding measures to be taken for the welfare and health of the horse.
4. Any medical fees incurred shall be paid by the owner of the horse and Grizzly Peak Stables shall have no liability therefore.
5. Grizzly Peak Stables, its agents or employees shall not be liable for any damage which may accrue from any cause or as a result of fire, theft, running away, state of health, injury to person, horse or property.
6. Owner agrees to abide by all the rules and regulations of the stable. No horse shall be allowed to be removed from the stable unless the bill is paid in full.

7. Owner agrees to keep all immunizations current and paste worm the horse not less than every eight weeks. If not kept current by the owner, worming and shots will be administered at clinics, and the owner billed with a \$10 handling fee.
8. Owner agrees to assume all responsibility and risk arising out of engaging or participation in equestrian activities at Grizzly Peak Stables and to hold its teachers, counselors, trainers, employees harmless from all damages or liability for any injury to person, horse or property arising for any reason whatsoever.
9. In the event someone other than the owner calls for the horse, such person shall have written authority signed by the owner to obtain the horse and/ or a Grizzly Peak Stables liability release form signed to ride.
